The third annual meeting of the "American, Boynton Association," will be in session at 9 o'clock A. M., on the 19th of August, 1885, in Horticultural Hall, No. 18 Front Street, Worcester, Mass.

It is hoped all bearing our names will be represented in person, or by letter, giving information of all marriages or deaths that have occurred since January 1st, 1883.

It was voted at our last Convention that our meeting this year should be a social, family picnic, each bringing refreshments. Worcester has ample accommodations, and many places of interest worth visiting, among which is "Boynton Hall," erected in memory of the late John Boynton, who bequeathed \$129,000 to found a "Free Institute of Industrial Science," to benefit the youth of Worcester County.

BOYNTON---ITEMS.

Our History, Genealogy and Pedigree extends over a period of nearly nine hundred years. Is there another family in America who can show such a continuous and unbroken lineage?

A large quantity of records and history of the Boynton familicshas been collected, and I fear will be lost if not published soon. A Committee of Ways and Means, with a Woman's Auxiliary Department, has been suggested to raise money for securing their publication. Who will take the lead and organize? Please give this a careful consideration, remembering our motto, "Time flies."

Is there not a wealthy Boynton, without heirs, who can do his kinsmen a favor, and rear a lasting monument to his own name by publishing our voluminous and valuable records?

As our printing and contingent expenses are paid by certificate holders, it is desirable that all who have not joined our Society, will sign the constitution, which will entitle them to a copy of the same, pay the fee of one dollar, and become registered members, or assist by voluntary donations.

Old letters, deeds, wills, commissions, &c., giving dates of Boyntons are desired. Bible and all other records are wanted, and the names of all Boyntons who are 70 years of age.

Who can furnish tombstone records of Boyntons? Whenever you find one, please send it.

All Boynton women, marrying into other families, should retain Boynton as middle name of their children. Why should a lady's name be obliterated by marriage? Why not perpetuate it with her offspring? My name should have been John Nichols Boynton, instead of John Farnham, as my mother was a Nichols.

What is your opinion about forming a Boynton Protective Life Insurance Association? Would it not have a tendency to preserve our history, social relations, and cause us to become more interested in each others' physical and moral welfare?

I have just returned from a five months' tour, Lecturing through the South. While there I gathered much valuable information; discovered several new families, and became acquainted with many of our name, most of whom can be traced to our original settlers of Rowley, Mass., in 1638. There are more than one hundred Boyntons in the State of Georgia. Judge James Stoddard Boynton, of Griffin, President of the Senate, and Ex-Governor, is expected to be present at our coming Convention.

THIS QUESTION HAS BEEN ASKED MORE THAN ONE HUNDRED TIMES: "What relation was the late President Garfield to the Boyntons?" I have been informed that one Caleb Boynton married a widow Garfield, with children. By her, Caleb had sons and daughters. These two families of children were reared together; when grown to manhood these half-brothers married sisters by the name of Ballou; one was the mother of James A. Garfield, the other was the mother of Dr. S. A. Boynton, who was the President's "old family physician," and was with him during his lamented illness. Who Caleb Boynton was, I have not determined, but am looking for records. Who can assist me?
