#### MESSAGES FROM THE GOVERNOR.

Mr. John Lester Wroe, Private Secretary to the Governor, appeared at the bar of the House and, being duly announced, presented the following messages from the Governor, which were read to the House, as follows:

#### Governor's Office.

#### Austin, Texas, April 30, 1915.

To the Thirty-fourth Legislature in Called Session:

You are perhaps advised that there is being held at San Francisco. California, the Panama-Pacific International Exposition. Most all States in the Union are having representation in some form or another. A former Legislature provided for the appointment of a Commission known as the Panama-Pacific International Exposition Commission. The regular session of your body appropri-ated \$25,000 to be spent under the direction of the said Commission and the Commissioner of Agriculture. However, the bill did not receive the necessary

once, and make the funds available for staff and Senator Cowell and the State immediate use. For this and other rea-sons I deemed it best to disapprove the bill, but at the time and now I still think the State should assist in this laudable purpose.

I submit for your consideration the question of making some appropriation of a much smaller amount than formerly made, and making the same available for immediate use.

In deliberating upon the question of how best to expend the public money, I desire to submit for your special consideration the necessity of setting aside a liberal amount for the cause of popular education, and the maintenance of the rural schools. You are quite well aware no doubt that this policy is strongly recommended by the Democratic party of Texas, especially set forth in the El Paso platform.

While you are being called upon to appropriate something in the neighborhood of four million dollars for the support of the Normal Schools, the Agricultural and Mechanical College and the State University, I am sure you will be equally as willing to be as liberal with those outlying school districts, where the people in their collective capacity are not able to maintain their country community schools.

I believe the people of Texas would be gratified to see your body appropriate a full million dollars, to be expended in the next two fiscal years in the support of the country schools. In order that the money would be sure to reach the rural communities, care should be taken that State aid thus extended should not be made to schools in towns of more than one thousand inhabitants. and should be restricted to schools having not over two hundred scholastics. The State Board of Education could administer and equitably distribute this fund in a way that most every country school in Texas would receive some of the appropriation. I think the amount should be restricted so that no one school should receive over one thousand dollars.

I beg to advise that in accordance with these general ideas your special way, and having certain and necessary

two-thirds so as to become effective at committee, composed of Hon. J. M. Wag-Superintendent, Hon. W. F. Doughty, to which gentlemen I am much indebted. have zealously co-operated with my department in the preparation of a bill specifically containing the ideas here expressed. I do not hesitate to say that I think the bill is an excellent one, and I trust that same will receive your favorable consideration and official approval.

While giving much attention to the higher education of the few, let us not neglect the proper education of the many.

Dear Sir: That part of your letter of the 3th in regard to loans upon real estate has been referred to this department for reply.

We are in the market for first-class loans upon real estate at about 40 per cent of the value of the property as placed by our inspector, at five years or longer at 10 per cent, and requiring the borrower to pay the expense of having the property inspected.

We will be glad to hear from you, if you have anything to offer on the above basis. I am,

This is the same company who filed report with the Commissioner of Insurance and Banking that they had six loans aggregating \$28,145.12 in the State of North Carolina, upon which they are charging an interest rate of only 6 per cent.

The Great Southern Life Insurance Company in their report to the Commissioner state that they loaned during the year 1914 fifty-seven loans, aggregating \$61,200, at 3 per cent, in Texas.

They further report that they have three farm loans, aggregating \$66,000, in the State of Oklahoma, made during the year 1914, for which they are charging a rate of only 64 per cent.

a rate of only 61 per cent. The Aetna Life Insurance Company of Hartford, Connecticut, in their report to the Commissioner, state that they made sixty loans. aggregating \$662,110, in Texas at 8 per cent. They also state in their report that they made three hundred and fifty loans in the State of Oklahoma for the year 1914 aggregating \$688,850 at 6 per cent.

The Union Central Life Insurance Company of Cincinnati, Ohio, in their report to the Commissioner of Insurnuce and Banking, state that they made in Texas during the year 1914 three hundred and twenty-six loans, aggregating \$780,156.25, at 8 per cent. They also state in their report that they made three hundred and forty-three real estate loans in the State of Oklahoma during the year 1914, aggregating \$475,789.02, at 6 per cent.

The Aetna Life Insurance Company has loaned in round numbers about eighteen million dollars in the State of Iowa at  $5\frac{1}{2}$  and 6 per cent. They have loaned in Texas approximately two and one-half million dollars at  $7\frac{1}{2}$  and 8 per cent.

Thus it is clearly shown that insurance companies are discriminating against the citizenship of Texas in the rates of interest which they fix upon loans.

I take the position unhesitatingly that any life insurance company being protected and chartered under the laws of Texas ought not in all good conscience be permitted to do business in Texas as long as they charge 10 per cent interest upon their real estate loans. The insurance companies derive their business as a result of the aid which the State gives their business. Therefore, they have no right to levy unrighteous charges upon the people of Texas.

Bearing in mind the above facts, I have decided to submit for your respectful consideration the passage of necessary and proper legislation regulating the rate of interest to be charged by life insurance companies doing business in Texas, so as to prevent extortionate charges in the way of interest. and I think the law should be fixed so that no life insurance company doing businesss in Texas should charge a rate of interest to exceed 7 per cent per annum, payable annually, and I trust that you will pass necessary legislation bearing on this question.
