sion, the sum of one thousand dollars was appropriated for the aid of country schools for the fiscal year ending August 31, 1918, and one million dollars was appropriated for the fiscal year ending August 31, 1919. It is well known that it was the intention of the Legislature to appropriate one million dollars for each of said fiscal years. It appears that the bill was improperly enrolled so as to read one thousand dollars for the first year and one million dollars for the second year.

Therefore, to correct such error, which is well known, I submit for your consideration the question of appropriating nine hundred and ninetynine thousand dollars for the aid of rural schools for the fiscal year ending August 31, 1918.

Messages From the Governor.

The Chair here laid before the Senate the following messages from the Governor received today:

Executive Office, Austin, Texas, April 23, 1917.

To the Thirty-fifth Legislature in Called Session:

Whereas, a simple resolution or request, signed by eighteen members of the Senate, has been presented to me, which resolution is as follows:

"Whereas, The Nation is now at war and all its available military force will probably be called out of Texas for the purpose of reorganizing new armies; and

"Whereas, Because of the geographical location or our State and its proximity to Mexico, it will be necessary for us to organize and augment the National Guard of Texas threefold, as early as possible, and to expend large sums of money in doing so; therefore, be it

"Resolved by the Senate, That we respectfully request the Governor to submit as a matter of legislation an appropriation of not less than 1,-000,000 for the purpose of the above set forth.

(Signed) "Robbins, Harley, Buchanan of Bell, McNealus, Clark, Buchanan of Scurry, Smith, Hall, King, Decherd, Johnson, Westbrook, Lattimore, Dayton, Hudspeth, Gibson, Woodward, Strickland."

Now, therefore, in pursuance of said request, and having in mind that the facts therein are true, and in view of the fact that a grave condition confronts our people, necessitating prompt and effective action, looking to the general protection of our people throughout the State, I therefore, submit to your consideration all the matters contained in said request or resolution for such

disposition as you may deem wise and proper at this time.

I also desire to submit for your consideration the matter of materially raising the salary of the Adjutant General of our State. Until the present crisis is over, the Adjutant General's office will be almost as important as any other office in our State government; certainly it will require the best man that can be obtained. I recommend that the salary for the next two years be very materially increased.

I also submit for your consideration the matter of permitting the increase of our ranger force. The present law only permits the enlistment of eighty men and officers. It may be that this would be sufficient, and yet, if any great number of the regular army and National Guard was withdrawn from our border, the condition might arise that the rangers would be our only protection; and I am sure the people of our State would feel more secure in such an emergency if it were known that the law permitted the enlistment of five or six hundred rangers. Provision should be made that they are to be paid only while in service.

Though the amount of money appears large at this time, yet Texas perhaps might be exposed to more danger than any other State in the Union. It has about nine hundred miles of land border and about seven hundred miles of Gulf border. T feel sure that I voice the sentiments of every true Texan when I say that the people of our Lone Star State are willing to do more than their part and to co-operate to the last man and the last dollar to relieve our Nation of as much concern and as much responsibility in this grave crisis as is possible or practicable. Impelled by one thought, one mind and one heart, we become one people under one flag, seeking but one glory and that the unconquered supremacy of Old Glory.

I am confident the passage of this law will increase the safety of train operation and in addition bring about a more rapid movement of freight, and the small additional expense caused in the first instance will be overcome in the actual saving.

The men who in their different capacities operate the railroad trains of the country are engaged in an occupation decidedly more hazardous than perhaps any other line of employment. These men are just as dear to their families as other men engaged in less dangerous occupations are dear to their families. We ought to be sure that the government has exercised due diligence in providing for the safety of the lives of these men.

The Council of National De-Sir: fense, as empowered by Act of Congress, August 29, 1916, is now engaged in the work of preparation for the war and in the co-ordination of the resources and energies of the Nation.

It holds itself in readiness to cooperate with the States to bring about the most effective co-ordination of activities and procedure for the general good of the Nation and the successful prosecution of the war and it invites the States to advise with it.

To further the prompt and energetic organization which the situation demands, it recommends the creation, by the States, of committees with broad powers, to co-operate with the Council-such committees to perhaps be known as State Councils of Defense-these committees to be representative of the State's resources.

Please advise us as promptly as possible of action being taken or contemplated in Texas in furtherance of the national defense. Please send us full information, with copies of all laws, proclamations and forms relating thereto.
