PROCLAMATION
BY THE
Governor of the State of Texas

TO ALL TO WHOM THESE PRESENTS SHALL COME:

Pursuant to the provisions of Article IV, Section 8 of the Texas Constitution, I, Mark White, Governor of Texas, do hereby call a special session of the 69th Legislature to be convened in the City of Austin, commencing at 11:00 a.m., Monday, the 8th day of September A.D., 1986, for the following purposes:

To amend H.B. 20, 69th Legislature, Regular Session, for the purpose of making spending cuts; and

Legislation amending the Tax Code to provide for a temporary 1½ cent increase in the sales tax on taxable items sold in this state, such increase to expire no later than August 31, 1987. We are unable to bridge the state's budget gap without raising revenue or reneging on the commitment we have made to invest in the education of our children—an investment that is critical to the future of our state. We must not retreat from the reforms we have made in our schools and the commitment to excellence we have made in our universities.
