

Author Submission Checklist

This checklist is intended to help authors quickly assess whether their manuscript is ready for submission and to reduce the chance that it will be unsubmitted for any issues. Full and more detailed author guidelines can be found on the journal websites:

General

- ☐ My manuscript fits the Aims and Scope of the journal.
- ☐ My manuscript has been edited for grammar, spelling, consistency, and clarity.
- ☐ (If necessary) I have worked with a language service such as [ENAGO](#) – our authors get 20% off their services.
- ☐ My manuscript is not being considered for publication elsewhere nor is it published elsewhere
 - The article may be posted on a preprint server. Do not post an updated version of the paper on the preprint server while it is being peer reviewed in the journal to which you submit.
- ☐ Data too large for print publication or exceeding the bounds of the manuscript has been included as supplementary files for review or in an online repository. If data is in a repository a link to it has been included.
 - If my manuscript includes images of western blots, full uncropped blots have been provided as supplemental data.
 - If there is any reason as to why the full data can't be provided, please include a statement as to why
- ☐ ***Review articles only*** At minimum one concept figure has been included.

My Title Page includes the following information:

- ☐ The full article title.
- ☐ The full list of authors. Complete names and academic affiliations are required for all coauthors.
- ☐ **All listed authors meet the criteria for authorship:**
 - Made a substantial contribution to the concept or design of the work; or acquisition analysis or interpretation of data.
 - Drafted the article or revised it critically for important intellectual content -
Approved the version to be published.

- Each author should have participated sufficiently in the work to take public responsibility for appropriate portions of the content. Please include a credit statement on your manuscript.
- When a large, multicenter group has conducted the work, the group should identify the individuals who accept direct responsibility for the manuscript. These individuals should fully meet the criteria for authorship.
- Acquisition of funding, collection of data, or general supervision of the research group alone does not constitute authorship although all contributors who do not meet the criteria for authorship should be listed in the acknowledgments.
- Please refer to the **International Committee of Medical Journal Editors (ICMJE) authorship guidelines** and **Contributor Roles Taxonomy (CRediT)** for more information on authorship.

Main Document

- ☐ My manuscript follows the required styling, i.e, margins, font, size, etc.

- ☐ My figures have been uploaded as separate image files (PDF, TIFF, JPEG, PNG). Figure resolution is 300 dpi.
- ☐ My tables have been uploaded as separate editable word files
- ☐ My manuscript includes the sections outlined in the manuscript [author guidelines](#)
- ☐ If my manuscript reports animal and/or human studies, the methods section includes relevant Ethics Committee or Institutional Review Board approval, including the full name and institution of the review committee

- ☐ Every in-text citation has a corresponding citation in the reference list and each reference list citation has a corresponding in-text citation. Corresponding citations have identical spelling and year
- ☐ All figures are numbered consecutively in the order in which they appear in the text — they will appear in the published article in the order they are numbered
- ☐ Graphs should include individual data points
- ☐ All figures include figure legends with individual group sizes indicated

What you will need to submit your manuscript

- Files: At a minimum, your main document, formatted using the checklist above and according to manuscript submission guidelines, and Title Page with all identifying information, as instructed above.
- Keywords
- Complete list of authors, with their institutional affiliations. See above for more information on what constitutes authorship
- The author information you enter via the submission system at submission must exactly match what is included on your Title Page, including full names, academic affiliations, and corresponding author contact details
- The corresponding author will need an ORCID ID. You can **sign up here** in a matter of seconds
- We strongly encourage all co-authors to link their ORCID ID to their accounts in our online peer review platform. It takes seconds to do: click the link when prompted, sign into your ORCID account, and our systems are automatically updated. Your ORCID ID will become part of your accepted publication's metadata, making your work attributable to you and only you. Your ORCID ID is published with your article so that fellow researchers reading your work can link to your ORCID profile and from there link to your other publications
- ORCID IDs must be added to co-author profiles on ScholarOne before the article is accepted. **They cannot be added to published articles retroactively**

This checklist is provided to help you prepare your submission. It should not be submitted along with your manuscript

Please check the manuscript submission guidelines for the journal to which you are submitting for all the full list of requirements. Before submitting you will be asked to generate and check your PDF proofs. Please take the time to carefully look through the proofs ensuring that all figures, formulas, and equations have converted properly/not been scrambled. If not spotted this may lead to delays or the manuscript being returned to you for correction.
